# For Question 1

- [F] (a) five strips of magnesium ribbon of lengths 2 cm, 3 cm, 4 cm, 6 cm and 7 cm labelled, 2 cm magnesium, 3 cm magnesium, 4 cm magnesium, 6 cm magnesium and 7 cm magnesium
  - (b) one 100 cm<sup>3</sup> beaker
- [H] (c) 150 cm<sup>3</sup> of sulfuric acid of concentration 1.0 mol/dm<sup>3</sup>, labelled dilute sulfuric acid
  - (d) one stirring thermometer, covering the range 0 °C to 110 °C
  - (e) access to water and distilled water
  - (f) one 25 cm<sup>3</sup> or 50 cm<sup>3</sup> measuring cylinder

## For Question 2

### Each candidate will require

- [H] (a) a stoppered test-tube containing a mixture of about 0.5g of zinc carbonate and 0.5g of ammonium chloride intimately mixed, labelled **mixture E** 
  - (b) one boiling tube and stopper
  - (c) rack of test-tubes
  - (d) a test-tube holder
  - (e) pH indicator papers and chart
  - (f) filtration apparatus
  - (g) splints
- [H] (h) limewater and apparatus to test for carbon dioxide
- [C] (i) aqueous sodium hydroxide of concentration 1.0 mol/dm<sup>3</sup>
  - (j) aqueous ammonia of concentration 1.0 mol/dm<sup>3</sup>
- [N] [H] (k) aqueous silver nitrate of suitable concentration to give a positive halide test
- [C] (I) aqueous nitric acid of concentration 1.0 mol/dm<sup>3</sup>
  - (m) aqueous hydrochloric acid of concentration 1.0 mol/dm<sup>3</sup>
  - (n) spatulas
  - (**o**) one 10 cm<sup>3</sup> measuring cylinder
  - (p) a Bunsen burner and matches
  - (q) teat pipettes
  - (r) access to water and distilled water
  - (s) a stop clock or timer, candidates may use their own watches

Labels do not need to include concentrations.
