### **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always **whole marks** (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

	<ul> <li>Low birth and death rates may assist future development because:</li> <li>Lead to population / economic stability;</li> <li>A lower birth rate puts less pressure on the economic resources, e.g. education and healthcare, food and housing;</li> <li>A low birth rate means a lower dependency ratio;</li> <li>Lower birth rate allows greater investment into agriculture, trade, industry, transport etc. which will eventually lead to economic growth;</li> <li>A larger proportion of 15–60-year olds will mean that there is a large proportion of the population available for work / economically active to contribute to increasing the revenue of the country / pay taxes;</li> <li>Lower death rate means that elderly people can help with child care / pass on wisdom / knowledge to younger generations;</li> </ul>	
	<ul> <li>Low birth and death rates may limit / hinder future development because:</li> <li>Lower death rate will mean there are more people living longer, which leads to an ageing dependent population may offset possible development from a lower birth rate;</li> <li>A higher proportion of elderly people will increase the need for investment in healthcare, care homes, pensions etc.;</li> <li>There will be an increased dependency ratio of older people to younger people and who contribute less to the economic growth of the country;</li> <li>A larger proportion of 15–60-year olds will mean that there is a large proportion of the population available for work / economically active but this could lead to high unemployment levels if there are not enough jobs available putting a further economic burden on the government;</li> </ul>
